

## Information for clients: OHP “Standard” benefits changing to “Plus”

### New in 2014

Adults with Oregon Health Plan (OHP) “Standard” health benefits will get a new benefit package on January 1, 2014. This new benefit package is called “OHP Plus.”

**Coordinated Care Organizations will stay the same**  
**Doctors and other providers will stay the same**

### What is OHP Plus?

OHP Plus is a benefit package that covers more services than OHP Standard. OHP Plus includes:

- Access to regular check-ups and preventive care
- Access to primary care doctors
- Mental health care services
- Some vision and dental care, and more

### How much does OHP Plus cost?

There is no monthly cost (or premium) for OHP Plus. Some of the new benefits may have a copay. For example, there may be a \$3 copay for some outpatient services and a \$1 or \$3 copay for some prescription drugs.

### What should people do if they have OHP Standard benefits now?

They don’t have to do anything. This change will happen automatically on January 1, 2014. More information will be mailed to you soon.

### How will clients be notified?

The Oregon Health Authority will send members who currently have OHP Standard benefits a letter in the mail. The letter will tell them about this change and more information about the new benefits. In January, we will also send a new “Coverage Letter” confirming the benefits change.

### How can people tell if they have OHP Standard benefits?

The benefit package you have now is listed on the Coverage Letter you received when you became a member of the Oregon Health Plan. If you no longer have that letter, please call OHP Client Services at 1-800-273-3767.

### Why is this happening?

This is happening because Oregon is opening the Oregon Health Plan to more people, as allowed under the federal health care law.

If you have OHP Standard, more information will be mailed to you soon.

This chart shows what benefits are available under OHP Standard and what benefits are available under OHP Plus. OHP Plus coverage depends on your age.
